Name : I. The name of the Society shall be the Montfort College Society.

Office : II. The principal Office of the Society shall be situated in the State of Karnataka. Its present address is Montfort College Society, Old Madras Road, Jeevan Bimanagar P.O., Bangalore - 560 075.

Objects : III. The Objects of the Society are :

- a) To promote Christian, philosophical and theological education and for the purpose to run it as a religious and educational institute, by the Brother of the Congregation of the 'Montfort Brothers of St. Gabriel', established in India.
- b) To facilitate the running of a Degree Course by the Faculty of Theology erected by Canon Law.
- c) To encourage students as part of their education to undertake social service activities and to provide facilities for the relief of the poor.
- d) To seek recognition of our studies and degrees by the civil authorities on a par with secular educational institutions of the same level.
- e) To provide residential accommodation, ~~either free of cost or for consideration~~

1) The profits, if any, shall not be distributed in any manner among its members.

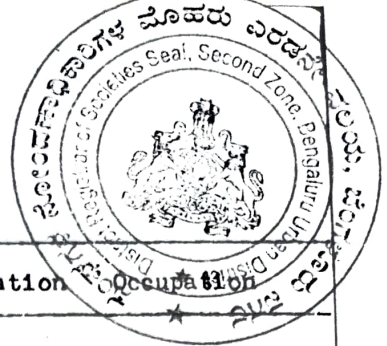

RULES AND REGULATIONS  
OF  
MONTFORT COLLEGE SOCIETY



1. Interpretation:

In these Rules and Regulations unless there is anything in the context repugnant or inconsistent therewith:

- a) "The Society" shall mean the Montfort College Society, Old Madras Road, Bangalore.
- b) "The Governing Body" shall mean the Governing Body of the Society constituted as provided by these Rules and Regulations.
- c) The Institute of the Brothers of St. Gabriel shall mean the Ecclesiastical Congregation executed under Canon Law.
- d) "The Provincial and Superior" shall mean the Chairman and Principal of the College.
- e) Code of Canon Law shall mean the Rules and Regulations for the time being in force in the Catholic Church.
- d) Words importing the singular shall be deemed to include the plural and vice-versa.

2. Membership:

The members of the Society shall consist of the fully professed members of the Congregation of the Institute of the Brothers of St. and who have attained the age of 18 years and above, Gabriel, shall be members of the Society. The Provincial shall be the ex-officio Chairman.

3. Fee:

No fees, subscription or contribution whatso-

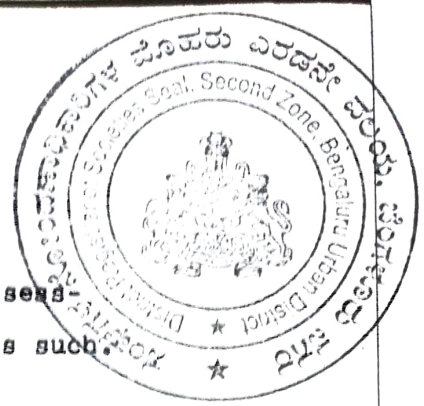

ever shall be paid by or shall be assessable on the members of the Society as such.



4. Binding power of Memorandum, Rules and Regulations:

Every member of the Society shall be bound by the provisions of the Memorandum of Association of the Society and these Rules and Regulations and the bye-laws and decisions from time to time made or taken by the Society in general body meeting or by the Governing Body.

5. Termination of Membership:

Membership of the Society shall ipso facto terminate if :

- a) a member dies, or leaves or is permanently excluded from the Congregation; or
- b) tender his resignation in writing to the Society; or
- c) his membership is terminated as provided by these Rules and Regulations.

6. Governing Body:

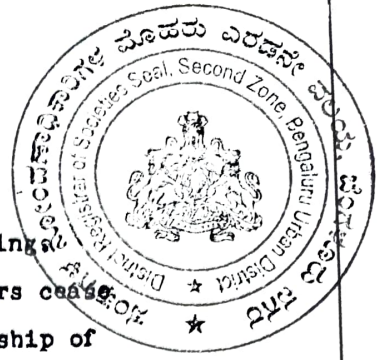
The management and control of the Society shall be vested in the Governing Body consisting of not less than seven members and not more than fifteen of whom the Provincial, Southern Province, shall be the ex-officio member of the Governing Body and the remaining shall be elected by the General Body from

among its members at its General Meeting. When the above mentioned office bearers cease to be the office bearers their membership of the Society and of the Governing Body is ipso facto terminated. In the event of vacancy arising among the members of the Governing Body, such vacancy shall be filled by the Governing Body from among the members of the Society within three months of date of vacancy arising. The Governing Body shall have the power to act notwithstanding any vacancy in its number.




7. Property and Income:

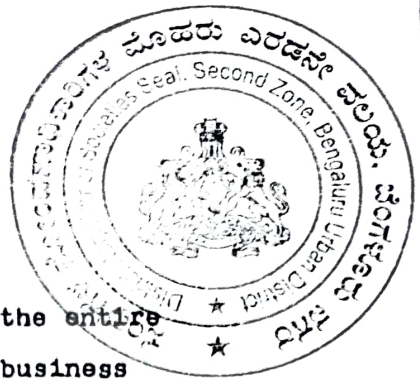
The property and the income of the Society shall be applied solely towards the promotion of the objects of the Society as set forth in the Memorandum of Association, and no dividend will be paid or distributed, of any income or profits among its members.

8. Chairman at Meeting:

The President, and in his absence the Vice-President and in the absence of both of them any member delegated by the President or Vice-President shall be the Chairman at all meetings of the Society and of the Governing Body. The President or the Vice-President shall convene all meetings of the Governing Body or of the Society at such time or place as he may deem fit.

9. Powers of the Governing Body:

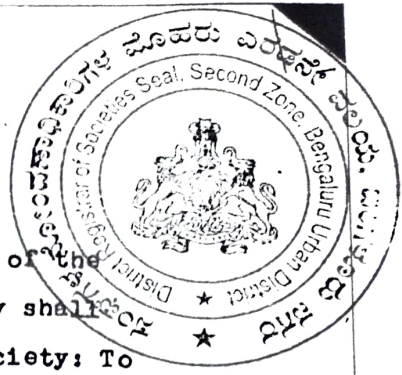
- a) The Governing Body shall have the entire control and management of the business of the Society and of its affairs, the administration of all its properties, movable and immovable and shall have all such powers of the Society and to do all such things to carry out the objects of the Society as are by the Act not required to be exercised or done by the Society in General Meetings.
- b) All the movable and immovable property of the Society shall vest in the Governing Body of the Society and all documents relating to such property shall stand in the name of the Society.
- c) All writings and deeds and documents which are to be executed by the Society shall be executed for and on behalf of the Society by the President or the Secretary or such members of the Governing Body who have been so authorised by a resolution of the Governing Body.
- d) The Governing Body shall have the power from time to time, to make, change and repeal its previous decisions for the transactions and the regulation of the business and the affairs of the Society and of itself and for the administration of the properties movable and immovable.

- e) Without prejudice to the generality of the foregoing powers, the Governing Body shall have the following powers of the Society: To support, establish and manage and administer such institutions as are needed for the educational activities.
- f) To purchase and take on lease, hire or otherwise, acquire or hold any movable or immovable property rights or privileges including agricultural land and to improve, alter or extend any or all of them which may be deemed necessary or convenient for any of the purposes of the Society.
- g) To build, maintain, repair, adapt, alter, improve, develop, furnish any buildings, structure or works considered necessary for the purpose of the Society.
- h) To open and operate accounts with any scheduled Bank or Banks in the interest of the Society, or such terms and such manner as the Society may deem it fit, either for the funds of the Society or those of any organisation or institution under its control.
- i) To borrow or raise money in any form deemed necessary and also to obtain donations and gifts for the purpose of the Society.
- j) To establish and maintain Reserve Funds of each amount as the Governing Body may think fit, for the promotion of the activities of the Society, including the extension of the buildings and structures.

k) To delegate all or any kind of the powers of the Society to the President or any member of the Governing Body as the Society may deem expedient or necessary from time to time.

l) To appoint a person or persons to represent the Society in any legal or other proceedings for or against the Society in any Court of Office throughout India in connection with the interest of the Society.

m) Generally to do, execute and perform all such acts, deeds and things as are incidental or conducive or may be so deemed by the Society to be incidental or conducive to the attainment of the above objects or any of them.

10. Officer Bearers:

Without prejudice to the generality of powers of the Governing Body the President, Vice-President, Secretary and Treasurer shall have the following powers:

A) CHAIRMAN:

- By
- a) He shall have all the powers of the Governing Body in case of an emergency and his decision shall be binding and shall not be questioned by the Governing Body of the Society.
  - b) The President may call for the accounts or inspect them or have them inspected from time to time.
  - c) He may summon extraordinary meetings of the Governing Body at short notice.
  - d) A circular resolution issued by the President

or Vice-President on any subject which is deemed urgent and signed by the President or Vice-President and the majority of the members of the Governing Body shall in all respects be valid and binding as a resolution passed at a meeting of the Governing Body duly convened and constituted and such resolution shall not be deemed invalid by reason of want of notice or any other cause whatsoever.

- e) All Bank accounts in the name of the Society shall be operated jointly by the President and the Treasurer for and on behalf of the Society.

B) Vice-President:

In the absence of the President he shall have all the powers of the President and those that are delegated to him by the Governing Body as and when necessary.

C) Secretary:

- a) He shall keep the minutes of the meetings, carry on correspondence on behalf of the Society and the Governing Body, prepare the annual report and issue notice and agenda of the meetings of the Society and any meeting of the General Body as directed by the President or in his absence by the Vice-President.
- b) He shall be responsible for the safe custody of the documents of the Society and for the safety and the maintenance of the furniture and the equipment of the registered office of the Society.
- c) The Secretary shall submit to the President a copy

of the scheme or project approved by the  
Governing Body.

- d) He shall be the person who may sue or be sued  
on behalf of the Society. All documents, sub-  
scription and money payable to the Society  
shall be paid to the Secretary whose receipts  
shall be valid and binding. He shall exercise  
all such powers and do all such acts, deeds and  
things as may be delegated to him by the Govern-  
ing Body or the President.

D) Treasurer:

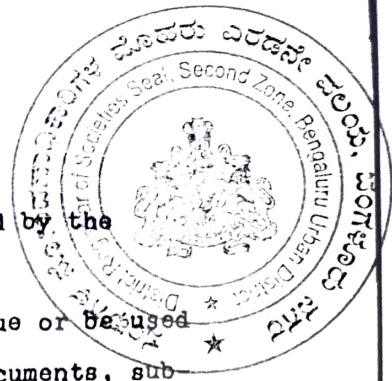
- a) The treasurer shall keep the account of the  
Society and shall submit the same to the Govern-  
ing Body before presenting it for the audit and  
present the budget to the Governing Body for the  
next financial year.
- b) After the General Meeting he shall file the  
audited balance sheet and the income and the ex-  
penditure accounts with the proper authorities.
- c) All Bank accounts in the name of the Society shall  
be operated jointly by the President (Chairman)  
and the Treasurer for and on behalf of the Society.

11. Meeting and Quorum of the Governing Body and General Body:

- a) Meetings of the Governing Body shall be held at such  
times and places as the President or Vice-President  
may from time to time determine. A quorum for a meet-  
ing of the Governing Body shall be one third members  
unless the Governing Body or otherwise decide.
- b) The quorum of all General Meetings of the Society  
shall be one third members of the General Body.

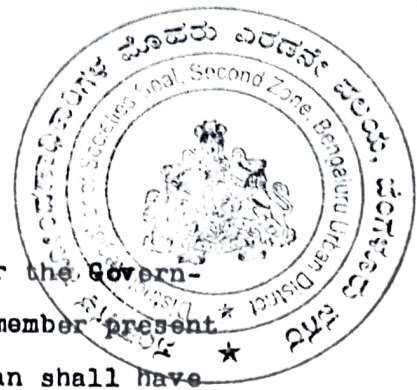

- c) At all meetings of the Society or the Governing Body or any committee every member present shall have one vote. The Chairman shall have a second or casting vote in case of an equality of votes. Voting by proxy shall not be allowed.



12. Annual General Meeting:

The annual General Meeting of the Society shall be held in the month of July or as near thereto as possible in each year at such time and place as the President (Chairman) or Vice-President may determine for the following purposes:

- a) To receive the report of the Governing Body, the accounts of the Society audits auditor's report for the year ending on the June 30th next preceding the date of the meeting. Such accounts shall comprise a Balance Sheet and statement of receipts and disbursement for the said year.
- b) To appoint an auditor or auditors and to fix his or their remuneration.
- c) To transact any other business which may be brought forward by any member of the Governing Body of the Society with the previous permission of the Chairman.

13. Extraordinary General Meeting:

The President may call an Extraordinary General Meeting of the Society whenever in his opinion he may deem it necessary.

14. Notice:

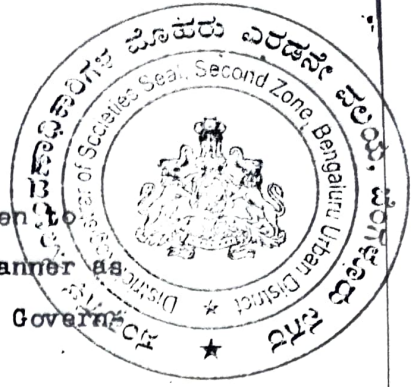

15. Dissolution:

In the event of the dissolution of the Society, the assets of the Society, after meeting liabilities, if any shall be disposed of as required by Section 23 of the Karnataka Societies' Registration Act, not inconsistent with the provisions of section 80G of the Income Tax Act, 1961.

16. Amendment:

Any alteration of the Memorandum of Association a change of name and Rules and Regulations shall conform Secs. 9 and 10 of the Karnataka Societies' Registration Act, 1960.

17. Accounts:

The year of the Society shall be from the 1st April of one year to the 31st March of the succeeding year.

18. The voting shall be conducted by show of hands or by secret ballot.

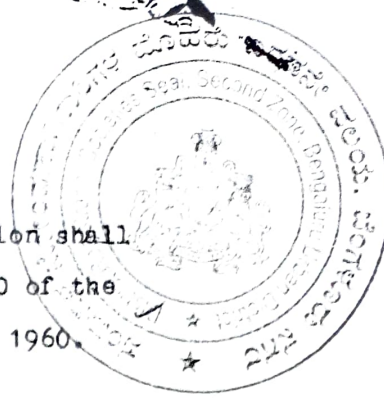
19. The working hours of the Society be between 9 a.m. 12 noon and 3 p.m. to 5 p.m. or as directed by the Governing Body.

23. Amalgamation and dissolution of the Society, if arises, Sections 21, 22 and 23 of the Karnataka Societies Registration Act, 1960 shall apply.
24. For all things and matters which have not been specifically provided for hereinabove, the provisions of the Karnataka Societies Registration Act, 1960 and the Rules made thereunder, shall apply.
